### Fiscal Crisis and Management Assistance Team (FCMAT)

- Created by the legislature in 1991 as part of the seminal Assembly Bill (AB) 1200 which introduced the financial reporting standards, fiscal oversight role, and receivership statutes.
  - Primary mission is to assist TK-12 schools and community colleges to identify, prevent and resolve financial, operational and data management challenges.
- Legislature has assigned additional responsibilities to FCMAT over time.
  - California School Information Services (CSIS) (1997).
  - AB 139 fraud reviews (2001).
  - Charter schools and community colleges (2006).





#### **FCMAT/CSIS Services**


- Services provided to local educational agencies (LEAs) include.
  - Management assistance.
  - Professional learning opportunities.
  - Product development.
  - Data management.
  - Fiscal crisis intervention.
  - Other services.
- Helps LEAs comply with fiscal accountability standards by promoting sound financial practices.





#### FCMAT/CSIS Services (Cont.)


- The FCMAT organization has 82\* full-time staff distributed between traditional FCMAT services and CSIS services.
- Additionally, CSIS depends on approximately 10 contractors who provide short-term or specialty services that are not readily accessible through the normal hiring process.

#### **Evolved Over Time to Focus on Prevention**

- FCMAT services have evolved over time to focus on prevention of financial and operational troubles, more so than responding to fiscal distress.
  - Management assistance and professional learning / product development account for approximately 80% of FCMAT's services and focus almost entirely on prevention.
  - FCMAT's management assistance, tools and resources are generally divided into two themes.

#### **FCMAT Governance**

- FCMAT is an external, independent agency of the state of California.
  - Operates under an administrative agent which is the Kern County Superintendent of Schools (KCSOS).
- Lead by a chief executive officer (four over the organization's history).
  - FCMAT staff are employed by the KCSOS.
  - FCMAT is funded by a state apportionment and fee-for-service revenue.





#### FCMAT Governance (Cont.)

- The governing board carries out advisory duties and members include:
  - State superintendent of public instruction.
  - Chancellor of the California Community Colleges and one community college district board member.
  - County and district superintendents.
    - Eleven each, one from each California County Superintendent (CCS) region.
    - Nominated by CCS and Association of California School Administrators.
  - Non-voting representatives from the California Collaborative for Educational Excellence and a charter school.





#### FCMAT Governance (Cont.)

- Board operates within adopted bylaws.

- Chair and vice-chair are selected from among the county superintendents on the board.
- Meets four times per year generally in concert with CCS quarterly meetings, follows Bagley-Keene Open Meetings Act (state agency).
